I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct:

\_\_\_\_\_ (initial) I, the undersigned, am the owner of the items that I am consigning and I have full authority to sell the items offered by me for the Just Between Friends sale event.

\_\_\_\_\_ (initial) I understand and agree that Just Between Friends of San Antonio NW and Just Between Friends Franchise Systems, Inc. are not responsible for **fire, loss, theft or damage** to the items I am consigning.

\_\_\_\_\_ (initial) I understand that JBF-San Antonio NW is only a broker or agent for the Consignor. JBF-San Antonio NW has no obligation to pay for unsold items. Title possession remains with the Consignor.

\_\_\_\_\_ (initial) I understand that I will earn 65% of my gross sales, less a \$10.00 Consignor Fee for participation in the JBF-San Antonio NW sale. I understand I will be charged an extra \$1 if I do not provide a self-addressed, stamped envelope. I understand that Consignors who volunteer for a minimum of 4 hours during the sale will earn an extra 5% of his/her gross sales. If volunteer shifts (4 hours minimum) are not fulfilled, the additional 5% will be forfeited.

\_\_\_\_\_ (initial) I request that JBF-San Antonio NW sell the items I am consigning for the price listed on the bar-coded tag that I have created. If there is NO star on the tag, I request that my items be sold at 50% of the tag price during the Half Price Sale.

\_\_\_\_\_ (initial) I verify that no item I am consigning is the subject of any current, pending or threatened recall notice according to the Consumer Products Safety Commission. Each item is in good operating condition and is not defective, broken or damaged in any way. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program. I know of no reason why any item would cause any injury to another. Finally, I am certain that each item complies with applicable law.
