I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends. I understand and agree that Just Between Friends (JBF) is not responsible for fire, loss, theft, or damage to my sale items. I also understand that I will be charged a \$10 consignor fee and 30-40% percent of my gross sales for participation. <b>For express drop off services I will pay an additional \$20 for up to 250 items or an additional \$30 for 251-500 items.</b>
Initial	<b>Consignor Pickup is Sunday, May 3rd, 2020 from 11:00am to 2:00pm. ID is required to pick up items.</b> I understand that any items not picked up during this time will be donated to JBF – Houston South's non-profit partner, <b>Forgotten Angels.</b>
Initial	I understand that, at times, JBF takes photographs of its events to promote sales. If I do not wish my image to be used in JBF promotions, I will notify the photographer at the time a picture is taken. Otherwise, I agree to allow my image to be used in JBF sale promotions.
Initial	I agree that, as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct: 1. I am the owner of the items to be sold and I have full authority to sell the items offered by me for sale. 2. Each item offered for sale by me is in good operating condition and is not defective, broken, missing pieces or damaged in any way. 3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program 4. <b>Each item complies with applicable laws (<a href="https://www.cpsc.gov/cpsclist.aspx">https://www.cpsc.gov/cpsclist.aspx</a>)</b> , and is not the subject of any recalls, pending recalls or threatened recall notice or other consumer protection enforcement action. 6. I know of no reason why any item offered for sale by me would cause injury to another.
Initial	I understand and agree to hold harmless and make no claims against Just Between Friends Franchise System, Inc., the Franchise Owners of Just Between Friends-Houston South, the Knights of Columbus, Pearland, TX, workers, helpers, or the insurer of Just Between Friends - Houston South for damage, theft, or loss of items consigned at JBF – Houston South or any and all claims of personal injury resulting from my participation in the JBF Houston South sale.

Tags with no star means the item will be sold at 50% off on <b>Saturday, May 2nd</b> . <b>For the consignor's protection, there will be no alteration to any tags (lowering/increasing price or adding/removing a star) allowed at any time during the sale.</b> The barcode tag is the deciding factor for any variation in price/information.
