St. Cloud Consignor Policies:

	I am participating in Just Between Friends St. Cloud sales event as a consignor/seller. I will not hold JBF St. Cloud responsible for fire, damage, theft, or loss of my sale items.
	I understand that I will earn 60% of my gross sales, less a \$15 consignor fee for participation in the JBF sale; I understand that consignors that choose to donate all unsold items will have their consignor fee reduced to \$10. I understand that consignors who volunteer for a minimum of 4 hours during the sale will earn an extra 5% of their gross sales; consignors who volunteer a minimum of 8 hours will earn an extra 10% of their gross sales and have their consignor fee waived.
	I understand that items that are stained, broken, damaged, missing pieces, missing batteries will be rejected at Drop-off at the discretion of the JBF Volunteers. I agree to take rejected items home and will not place them on the sales floor. JBF reserves the right to remove unacceptable items from the sales floor throughout the sale.
	I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct: <ol style="list-style-type: none"> 1. I am the owner of the items to be sold, and I have full authority to sell the items offered by me for sale; and 2. Each item offered for sale by me is in good operating condition, reasonable wear and tear expected, and is not defective or broken in any way; and 3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and 4. Each item complies with applicable law; http://cpsc.gov/cpsclist.aspx; and 5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and 6. I know of no reason why any item offered for sale by me would cause any injury to another.
	I understand that a "star" ★ printed on JBF tags mean that the item will remain FULL PRICE throughout the sale. Tags with no star means the item will be sold at 50% off on Sunday (and after 6PM Saturday for the Half Price Presale). For consignors' protection, alterations to the tags (lowering/increasing prices or add/removing a star) WILL NOT be accepted at any time during the sale. I understand that if my items are marked "donate" they could be sold during the 75% off sale. If I choose for my donated items NOT to be sold at 75% and want them donated directly, I will mark them for FULL PRICE indicated with a star.
	I understand that while participating in JBF as a shopper, consignor, or volunteer I may be photographed or filmed. I give JBF St. Cloud my permission to use photos or videos of me, or in which I may be included, for any publicity avenue they so choose without my prior inspection or approval.
	Consignor Pick Up (of unsold items you choose not to donate) is Monday October 1 st from 4pm-6pm. I understand that any of my items not picked up by 6:01pm will be donated to A Place of Hope, St. Cloud. I will receive a tax donation receipt mailed with my consignor check.
	I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct. I am the owner of the items to be sold, and I have full authority to sell the items offered by me for sale; and each item offered for sale by me is in good operating condition, reasonable wear and tear expected, and is not defective, broken or damaged in any way. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and each item complies with applicable law; and no item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and I know of no reason why any item offered for sale by me would cause any injury to another.
