Initial _____	I am participating in the Just Between Friends Consignment (JBF) Sales Event as a consignor. <i>I will not hold JBF responsible for fire, loss, theft or damage to my sale items. A \$10.00 consignor fee & 40% of my gross sales for participation (30% if I volunteer 4 hours or more at this event) will be deducted from my profit check.</i>
Initial _____	I understand that if I bring > 300 items to sell and wish to have them included in the sorting process, I am required to attend the Mandatory 300+ items consignor shift (see online Volunteer Schedule). The required shift DOES count towards volunteer credits. Failure to participate will result in a 5% penalty which will be reflected in my profit check.
Initial _____	Consignor pickup (of any unsold items) is scheduled SUNDAY June 16th from 7pm-9pm. No early entry, no phone calls, no late pick-ups, no exceptions. Don't be late! I also understand that any items marked "DONATE" and all items not picked up before 9pm will be donated at 9:01pm. I will bring my ID to pick up my items.
Initial _____	RETURNING THIS SALE! I understand that all items marked "DONATE" will be sold at 75% off during the Post Event sale. This is one last attempt for me to make money on my items.
Initial _____	I understand that I am eligible to shop during the Consignor Pre-sale @ 4:00pm on Wednesday June 12th . I am also eligible to shop the 50% off pre-sale @ Saturday June 15th at 5pm . I may bring one guest to each pre-sale. I can choose to volunteer during the sale for an additional 10% on my sold items & earlier presale shopping privileges.
Initial _____	I am participating for the sole purpose of selling my items as a consignor. I am participating in an ethical manner and agree that I am not attempting to learn the business practices of JBF, operations techniques or any other business matters that may or may not be trademarked, registered or proprietary in any way. I understand that, at times, JBF takes photographs of its events to promote sales and if I do not wish for my image to be used in JBF promotions, I will notify the photographer at the time a picture is taken. Otherwise, I agree to allow my image to be used.
Initial _____	<p>I understand that as a condition of selling items in a JBF consignment sale, I represent the following to be true and correct:</p> <ol style="list-style-type: none"> 1. I know of no reason why any item offered for sale by me would cause injury to others.
