I am participating in the Fall/Winter 2018 Just Between Friends Lubbock Consignment Sales Event as a consignor/seller. **I understand and agree that Just Between Friends (JBF) Lubbock, LLC, or Courtney Kattner, as an individual, is not responsible for fire, loss, theft, or damage to my sale items.** I also understand that I will be charged a \$10 consignor fee and 35 percent of my gross sales for participation (30% if I volunteer four hours or more at this event).

I agree to cash my JBF Consignor check within 90 days of the date that the check is issued.

★ A "star" (printed on JBF barcode tags with black or red ink) means that the item will remain FULL PRICE throughout the sale. Tags with no "star" means the item will be sold at 50%. **For YOUR protection, there will be no alteration to any tags (lowering/increasing price or adding/removing a star) allowed at any time during the sale.** \*\*The barcode tag is the deciding factor for any variation in price/information.\*\*

If I am also volunteering and I do not show up to work my shift, **I will not be given the additional 5% on my sold items.** I also understand I may lose Presale privileges at future sales.

**No children, except breastfeeding infants and children with disabilities confined to a stroller or wheelchair, are allowed at the pre-sale THURSDAY, SEPTEMBER 13, 2018.**

I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct:

1. I am the owner of the items to be sold, and I have full authority to sell the items offered by me for sale.
2. Each item offered for sale by me is in good operating condition, reasonable wear and tear expected, and is not defective, broken or damaged in any way.
3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program.

5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action.
6. I know of no reason why any item offered for sale by me would cause any injury to another.

I am participating for the sole purpose of selling my items as a consignor. **I am participating in an ethical manner, and agree that I am not attempting to learn the business practices of JBF, operations techniques or any other business matters that may or may not be trademarked, registered or proprietary in any way.** I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends.

I understand that consignor pick-up (for any unsold items) is **Sunday, September 16, from 8pm-9pm.** I understand that any items not picked up during this time will be donated to *Parent Life Lubbock* at **9:01pm.** I am not able to pick-up my items, but \_\_\_\_\_ will be picking up for me.
