<div>Initial</div>	I am participating in the Just Between Friends Consignment Sales Event as a Consignor/Team Member. I understand and accept that Just Between Friends is not responsible for fire, loss, theft, or damage to my sale items. I understand that Consignors who help at the sale for a minimum of 5 hours during or before the sale will be charged only 30% of his/her gross sales, less a \$10.00 Consignor Fee. I understand that I will be charged 40% of my gross sales, less a \$10.00 Consignor Fee for participation if I chose not to help at the sale for a minimum of 5 hours.
<div>Initial</div>	Consignor Pick Up (of unsold items you choose not to donate) is Monday, March 23rd from 4pm to 7pm. Doors will remain locked until 4pm. I understand that any items not picked up by 7:01pm will be donated to the JBF Charity Partner.
<div>Initial</div>	I understand that items that are off-season, stained, broken, missing pieces or missing batteries will be rejected at Drop Off at the discretion of JBF Team Members and Staff.
<div>Initial</div>	I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct: <ol style="list-style-type: none">1. I am the owner of the items to be sold, and I have full authority to sell the items offered by me for sale; and2. Each item offered for sale by me is in good operating condition, reasonable wear and tear expected, and is not defective, broken or damaged in any way; and3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and4. Each item complies with applicable law; http://www.cpsc.gov/cpsclist.aspx; and5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and6. I know of no reason why any item offered for sale by me would cause any injury to another.
<div>Initial</div>	★ I understand that a "star" (printed on JBF tags with red or black ink) means that the item will remain FULL PRICE throughout the sale. Tags with no star means the item will be sold at 50% off on Sunday (and Saturday after public sale day has closed; during the half price presale). For consignors' protection, alterations to the tags (lowering/increasing price or adding/removing a star) WILL NOT be accepted any time during the sale.
<div>Initial</div>	If I am helping during the sale, I will arrive 10 minutes early for my shift so that I can park my car and be ready to work my full shift. If I am unable to fulfill my full team member commitment, I will find a replacement and call Christy at 972-342-1606. I will check in and out for every shift in writing at the Team Member Table. I am helping for the sole purpose of assisting with operations of the event for my own advantage in gaining entrance to Presales and receiving a higher percentage of my consignor sales. I am helping in an ethical manner and agree that I am not attempting to learn the business practices of JBF, operations techniques, or any other business matters that may or may not be trademarked, registered or proprietary in any way. I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends.
