Initial	<p>I am participating in the Just Between Friends Consignment Sales Event as a Consignor/Volunteer. I understand and accept that Just Between Friends is not responsible for fire/loss/theft/damage to my items.</p> <p>I understand that Consignors who volunteer for a minimum of 4 hours during or before the sale will receive 70% of sold items price less \$14.00 consignor fee. If I volunteer a 4 hr. regular shift & a 4hr breakdown shift I will get my \$14.00 consignor fee waived.</p> <p>I understand that I will receive 60% of sold items price less \$14.00 consignor fee. For participation If I am unable to volunteer for a minimum of 4 hours.</p>
Initial	<p>Consignor Pick Up (of any unsold items I choose not to donate) is Sunday, March 31st from 5pm - 6pm. I understand that any items not picked up by 6:01pm will be donated to the JBF Charity Partner.</p> <p>I understand that I alone am responsible for picking my items up, JBF is not responsible for storing any items or notifying /calling to remind me to pick up on March 31st.</p>
Initial	<p>Items that are too worn, stained, broken, missing pieces or not working will be rejected at Drop Off at the discretion of JBF Volunteers and Staff. Items are expected to have working batteries. The consignor will be charged \$1/battery if we have to change/replace to test the item for it to sell.</p> <p>We will have rejected items for consignor at pickup.</p> <p>JBF reserves the right to remove unacceptable items from the sales floor throughout the sale.</p>
Initial	<p>I understand that as a condition of selling items in a Just Between Friends Consignment Sale, I represent the following to be true and correct:</p> <ol style="list-style-type: none"> 1. I am the owner of the items to be sold and I have full authority to sell the items offered by me for sale; and 2. Each item offered for sale by me is in good operating condition, reasonable wear and tear accepted, and is not broken or damaged in any way; and 3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and 4. Each item complies with applicable law, https://www.cpsc.gov/cpsclist.aspx; and 5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and 6. I know of no reason why any item offered for sale by me would cause injury to another.
Initial	<p>I understand that a "star" (printed on JBF tags with red or black ink) means that the item will remain at FULL PRICE throughout the sale. Tags with no star means the item will be sold at 50% during 50% off presale, and 50% days. For consignors' protection, alterations to the tags (lowering/increasing price or adding/removing a star) will NOT be accepted any time during the sale.</p>
Initial	<p>If I am volunteering, I will arrive 10 minutes early for my shift so that I can park my car and be present for my full shift. I will check in and out for every volunteer shift at the Volunteer Table, if I fail to do so I WILL NOT RECEIVE THE EXTRA PERCENTAGE associated with volunteering.</p> <p>I am volunteering for the sole purpose of assisting with operations of the event for my own advantage in gaining entrance to Presales and a higher percentage of my consignor sales. I am volunteering in an ethical manner and agree that I am not attempting to learn the business practices of JBF, operations techniques, or any other business matters that may or may not be trademarked, registered or proprietary in any way. I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends.</p>
