I, the undersigned, understand and agree that **JBF Reno LLP** ("JBF Franchisee") and Just Between Friends Franchise Systems, Inc. ("JBF Franchisor") is not responsible for **fire, loss, theft** or **damage** to the items I am consigning.

I understand that I will earn 60% of my gross sales, less a \$20 Consignor Fee for participation in the JBF Franchisee sale.

I understand that Consignors who volunteer for a minimum of 4 hours during the sale or perform an approved barter will earn an extra 10% of his/her gross sales.

I agree to cash my JBF Consignor check within 90 days of the date that the check is issued.

I request that JBF Franchisee sell the items I am consigning for the price listed on the bar-coded tag I have created. If there is NO star on the tag, I request that my items be sold at the discounted tag price during the 50% off sales. I verify that I have no hand-written information on any tags.

If I am also volunteering and I do not show up to work my shift, I may lose pre-sale privileges at future sales. I will also **not** receive the additional percentage on my sold items if I do not complete my volunteer responsibilities.

I agree that as a condition of selling items in a Just Between Friends Consignment Sale, I represent and warrant the following to be true and correct: I am the owner of the items to be sold, and I have full authority to sell the items offered by me for sale.

Each item offered for sale by me is in good operating condition, reasonable wear and tear expected, and is not defective, broken or damaged in any way.

Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program.

No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action.

I know of no reason why any item offered for sale by me would cause any injury to another.

I am participating for the sole purpose of selling my items as a consignor. I am participating in an ethical manner, and agree that I am not attempting to learn the business practices of JBF, operations techniques or any other business matters that may or may not be trademarked, registered or proprietary in any way. I am willing to sign a confidentiality agreement and will do so if asked by a representative of Just Between Friends.
